Extended Program Form

- ☆ Extended Program form must be signed for every child, regardless if you are registering the child for the extension or not. If you do not wish to register the child for any of the extended programs, simply check mark the box on the Registration (the other side of this form) stating that you will not do so and sign the form.
- ☆ Without registration, you are automatically charged the daily extension fee for each day you pick the child up more than 5 minutes late. If you are late after 7pm without registration, you will be charged for both the extension from 6pm – 7pm and extension from 7pm – 10pm. Late pick up fee after 10pm and on Saturday is \$1 per minute.
- ☆ If you know you will not be able to pick the child up by 6 pm two or more days a week, we encourage you to register for the extension. Registration for the extension is available throughout the year, but the form has to be submitted prior to the child starting the extended program. You may cancel the extended program with a notice a week prior to the child leaving the extended program. If you wish to make changes to the Extended Program Registration, new form has to be filled out.

Extension from 6pm – 7pm
\$10 per week (with registration)
\$5 per day (without registration)

Extension from 7pm – 10pm
\$50 per week (with registration)
\$25 per day (without registration)

Saturday Extension from 10am – 3pm
\$50 per week
